In memory of Robin Bevitt

Many Pearl pensioners will be saddened by the news of the death of Robin Bevitt, a former Company Solicitor and Company Secretary, at the age of 82.

Robin joined the Solicitors Department of Pearl in 1947. He qualified as a Solicitor in 1965 and succeeded Edward Blythe as Company Solicitor in 1979.

Robin and his wife Jean moved from Essex to Milton, near Cambridge in 1989 when Pearl relocated to Peterborough. He retired in 1993 after 46 years service.

In 2000, Robin was appointed Chairman of the Pearl Chief Office Pensioner's Association and served in that capacity for six years. Many Chief Office Pearl pensioners will recall Robin presiding at a function at the former Chief Office building in High Holborn after it had been transformed into a luxury five-star hotel. This event, in 2005, was in recognition of the Pensioner's Association completing 40 years of existence.

In 2001, Robin was proud to present the hotel management with a plaque, on behalf of all Pearl Chief Office Pensioners, commemorating Pearl's occupancy of the building from 1914 to 1989. Sadly, poor health prevented Robin from attending reunions in recent years.

Robin was a very friendly, approachable man and his knowledge and experience proved invaluable to many. He had a presence about him and an infectious laugh. He will be greatly missed.

Geoff Delany, who succeeded Robin as Pearl Group Solicitor and Company Secretary, paid tribute to Robin at the funeral service. Geoff summed up Robin as a big man with a big heart who had a wonderful sense of humour. Geoff acknowledged that Robin would be remembered with great affection by his many Pearl colleagues and friends.

On behalf of all Pearl pensioners, we would like to convey our sincere condolences to Jean and all her family.

PCOPA

66 members were at the Victoria Services Club on 13 May for the 49th AGM of the Pearl Chief Office Pensioners Association. Much of the formal part of the meeting was given over to a discussion on the celebrations planned to mark the 50th anniversary in 2015.

Before this, however, a moment was taken to remember the 18 members who had died since the reunion in October last. These included our previous Chairman, Robin Bevitt, and Joan Lawrence, aged 95, one of the founders of PCOPA all those years ago. Joan worked all her life at the Pearl in various



Life departments and was a leading light in the Pearl Office Guild. In fact, she was the first woman to take the Chair of this staff union. She fought for equal pay for women when it was regarded as a no-go area and set up PCOPA in the hope that it would negotiate on behalf of Pearl Pensioners. The first objective was achieved but the management at the time did not want to go down this route, so this association has always been a social rather than a representative body.

In retirement she was active in many local charities and in her church; tributes from many of these organisations were paid at her funeral.

I have a very special regard for Joan, as it was she who first talked me into becoming OB4 departmental POG representative, telling me it

would not take up much of my time. I then went on to spend the last 30 years of my working life as a full time Trade Union Officer!

After this moment of reflection, the PCOPA President enlivened matters by reminding us all that it was 150 years since the Company was founded and 100 years since 252 High Holborn was opened. He led the meeting in a toast to the Pearl Assurance.

The reduction in membership for an association whose members need to have worked at CO High Holborn, City, West End or a Regional Office before 1989 is not surprising but nevertheless almost 200 members and guests have indicated an interest in attending a lunch next year on 10 October 2015 at our old and much loved office, now a five-star plus hotel. The event will have a small subsidy for members from PCOPA funds and anyone who joins us in the next 16 months will, of course, benefit



End of an era within the X-Div Pensioners Association

Ray and Marion Ridout have been married for 56 years and are a very friendly, popular, family-oriented couple with four sons, 15 grandchildren and two great grandchildren.

In his 'spare' time, Ray has nurtured an allotment for the past 46 years. You would be forgiven for thinking that with a family of that size, an allotment, full time employment with the Pearl and the duties incumbent in his role for several years as Secretary of the X-Div Agents Union, Ray had enough on his plate. However, some people seem born to be organisers while others are happy to be organised. Ray Ridout is a champion amongst the former.

In 1978 I discovered he also managed a youth football team, a role he undertook for 15 years. 
Horsepower - at both ends of the spectrum!

I first became involved with horses in my early teens, but my interest soon faded when my father introduced me to motorcycling.

Since leaving Pearl I have worked on a part time basis for a local motorcycle shop and have had the opportunity to ride bikes from 50cc up to 2.3 litres. Today's modern motorcycles are 'rocket ships' compared to the bikes of the sixties, of which I have three classic Royal Enfields. I also own a modern motorcycle capable of 180mph.

One of the most memorable bikes I borrowed for a 'demo' was a Kawasaki ZZR1400, today the most powerful production motorcycle ever made for the road. For the technically minded it has a 1,441cc inline 4-cylinder engine, with a power capacity of 193bhp, capable of 186mph. All motorcycle manufacturers have an unofficial agreement to govern the speed potential of their road bikes to 186.3 mph, although for racing motorcycles, 200mph plus is the norm. An incredibly fast bike and in the right hands it will,

I am told, go from 0 to 170mph in 7.5 seconds.

At the other end of the 'horsepower' spectrum, I volunteer at Sacrewell Farm and Country Centre and look after the heavy horses, which are a mix of Shire Horses and Clydesdales. The Shire horse is the largest of these, typically 18 hands high, which is measured from the ground to the withers, or shoulders, just at the base of the horse's mane, and a horse at 18 hands will stand at six feet. The Shire horse weighs about a ton and is immensely strong and powerful, with the ability to pull twice his body weight.



One highlight for me with the Shire horses was meeting the Lord Mayor of the City of London in July 2012, at the Carriage Marking ceremony at the Guildhall. I was invited to walk a single horse pulling a Victorian rubbish cart. The Cart Marking ceremony is an old tradition in which all horse drawn vehicles travelling through the City of London had to have a 'cart mark' to allow them to travel over the roads. Today it is not a requirement of law but the tradition is kept in place and monies raised go to charitable causes in the City of London. The Lord Mayor brands all vehicles with a 'cart mark' and then inspects the vehicle and also, in my case, Comet the horse, and after a brief word he shook my hand and thanked me for attending the event.

I have prepared horses for Agricultural Shows and each horse can take over two hours work, as he will need to be bathed and the feathers

(silky white hairs) on his fetlocks washed out and dried with wood flour to make them as white as possible. Finally he will need to be groomed and sometimes his mane and tail will need to be trimmed and then plaited with decorative flights and ribbons. The horses can do ridden displays, and can be demonstrated singly, in pairs and teams of four pulling agricultural equipment, carriages and drays. At most of the Agricultural Shows I have attended, the Master of Ceremonies will read out the 'Horse's Prayer' before the horses leave the show ring.

Matters of interest

State pensions – an update

In the last issue of Pension News we covered the subject of the then Pensions Bill 2013/14, the most notable purpose of which was to introduce a new single tier State pension to replace the current system of State pension.

On 14 May this year, the Bill was given royal assent and became the Pensions Act 2014. This means that, as planned, the changes legislated for in the Act will go ahead, including the launch of the single tier State pension on 6 April 2016.

New scheme to top up Additional State pension

The Chancellor has now announced further details of a new scheme of Voluntary National Insurance contributions (VNICs) to allow pensioners to buy credits to top up their Additional State Pension.

The scheme will run from October 2015 to April 2017 and will introduce Class 3A voluntary contributions. This will provide those currently receiving their State pension and those who will reach their State pension age before 6 April 2016 with a means to improve their State pension by paying a fixed lump sum in return for a higher weekly rate of State pension than they would otherwise receive. The usual rules on Additional State Pension will also apply to the Class 3A contributions, meaning that a surviving spouse or civil partner will be entitled to inherit at least 50% of the Additional State Pension.

Crackdown on call costs

The Department for Work and Pensions (DWP) is one of many government departments which has started to introduce alternative 0345 phone numbers for its major helplines – including those for the State Pension and Carer's Allowance. The new 0345 numbers will be cheaper for many people to use, especially for those calling from mobile phones.

However, the DWP will continue to offer 0845 numbers as well, because these might still be cheaper for some callers, particularly for landline users. They will also introduce an 0345 number for the Welsh language service. The current freephone 0800 numbers will also remain for all major claim lines, including the State Pension and key benefits. The cost of calling either an 0845 or 0345 number depends on the terms of an individual's mobile or landline phone contract.

Good news for savers

From April 2015, the 10% 'starting' tax rate for savers will be abolished. At present, the first £2,790 of savings income above the tax-free personal allowance is taxed under this starting rate. From next April, this amount will be raised to £5,000, which, in addition to the increased tax-free personal allowance of £10,500 next year, will mean that anyone with total annual income of less than £15,500 will no longer pay tax on their savings income.

Additionally, the government plans to launch a choice of fixed-rate, market-leading savings bonds for people aged 65 and over, from January 2015. They cited an example of a three-year bond paying 4.0% gross/AER, with an investment limit of £10,000 per bond.

Interest on the bonds would be taxed in line with all other savings income, at the individual's marginal rate, meaning that pensioners who do not pay savings tax will be eligible to receive the interest tax-free. Further details will be confirmed in the 2014 Autumn Statement.

Could you be a volunteer?

The charity Age UK estimates that around one million older people in the UK regularly go without speaking to anyone for a month.

There are many charities across the UK that aim to provide services to tackle loneliness among older people and the vast majority welcome applications from volunteers. Those willing to offer their time can be put to use as telephone befrienders or visitors, or could provide essential help and support towards services such as lunch clubs, day trips, community transport, social activities or classes. In addition, some charities run local shops and welcome volunteer shop staff to help things run smoothly.

Volunteering can be arranged to fit around your lifestyle, with agreed hours to suit you, and you may find you have certain skills which lend themselves to particular aspects of volunteer work. As well as helping others, you may also find that volunteering provides you with a sense of achievement and can, in turn, help you to meet other people and form new friendships.
